- 1. A Resolution of Application as entitled above was received by the Executive Officer of the Local Agency Formation Commission (LAFCo), County of Kern from: *Lost Hills Community Services District*.
- The affected proposed area is located: Beginning 2 ½ miles west of State Highway 33 and 2. the north Kern County Line; proceeding east for approximately 20 1/2 miles to 1 ½ miles east of Lost Hills Rd., then meandering south for 9 miles between 1 to 2 miles east of Lost Hills Rd. then east for two miles, then meandering south for 3 miles to State Highway 46. then west to Interstate 5, then meandering south, staying east of the California Aqueduct and west of Main Drain Rd. for 10 miles, then west for 2 miles, then south for 2 miles to Seventh Standard Rd., then west for 6 $\frac{1}{2}$ miles, then meandering north and 1 mile west for 4 miles, then west for 5 miles, then north for 4 miles, then east for 3 miles, then north and $\frac{1}{2}$ mile east for 4 miles to State Highway 46, then then west to State Highway 33 for 3 ½ miles, then meandering west generally along State Highway 46 and 1 mile south for 5 miles, then meandering north west between State Highway 46 and 1 mile north of State Highway 46 for 5 ½ miles, then meandering north 2 miles, then meandering east and north for 4 miles, then north for 2 ½ miles to Twisselman Rd., then west generally following Kecks Rd. for 2 ½ miles, then north and ½ mile west for 4 ½ miles to the Kern County line.
